"Slavery & Servitude" includes all forms of exploitation; Sexual, Criminal, Financial, Forced Marriage, Radicalisation, FGM, illegal adoption & Domestic Servitude


### The NRM (National Referral Mechanism):

- From 30.01.23, the 'test' of whether a person was a victim of Modern Slavery or not, was amended.
- The decision maker/s must agree that based on 'objective factors', there are 'reasonable arounds to believe that a person is a victim of modern slavery'.
- From 10.07.23, the test was further amended; the test remains an objective one.
- The decision maker must agree with the statement that there are "reasonable grounds to believe that a person is a victim of modern slavery".
- This takes the victim's account into consideration and any other relevant information to • consider whether, in the circumstances of the case, it is reasonable to expect supporting information to be available.

# The NRM (National Referral Mechanism):

- A total of 8,156 referrals were made to the National Referral Mechanism reporting exploitation entirely within the UK between October 2023 and September 2024.
- A total of 4,415 referrals (54%) were for UK nationals
- 58% (4,697 of 8,156) of referrals, the potential victim reported exploitation as a child.

# Technology Assisted Child Sexual Abuse (TACSA):

- Social media & gaming platforms encompass a wide range of communication & file sharing features
- Lack of safety measures (robust age verification, effective moderation processes &/or reporting mechanisms)
- The deployment of end-to-end encryption without appropriate mitigations on social media platforms can undermine Safety by Design and impairs industry ability to identify child

• Identification of indecent/abusive images of children continues to increase

#### Internet Watch Foundation (IWF):

- In 2024 the identification of 291,273 webpages confirmed as containing indecent images of children
- A 6% increase since 2023
- 91% were classified as 'self-generated indecent imagery' (shared consensually/ via manipulation)
- Most common age 13 to 14
- Continued upward trend in reports of under 10's (ages 7-10)
- Financially motivated sexual extortion of children predominantly affects young males
- 90% victims were 14 to 17 yr old male

### Human Trafficking

"The recruitment, transportation, transfer, harbouring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation"

# ACT MEANS PURPOSE

Modern Slavery/ abuse through exploitation occurs when someone controls or manipulates you into doing what they want using a process called grooming.

#### What is Grooming:

Grooming is when a person (the perpetrator or abuser) builds a connection with a child, young person or adult, or someone close to them so they can abuse them.

Often this is done using threats, coercion, trickery or gifts. This means that abuse by exploitation can occur even when it appears consensual or if the victim doesn't recognise what's happening as abuse.

- Being a child
- Prior experience of neglect or abuse
- Permanent or temporary exclusion from education
- Lack of positive role models
- Environmental vulnerability
- Economic vulnerability
- A want to be accepted
- Family member or friends who are exploited
- Having additional needs (physical and learning)
- Having mental health or substance misuse challenges
- Approaching 18 years of age
- Low school attendance
- Low educational attainment
- Being accommodated by social care
- Not being known to the Services

# 'Grooming is subtle and is different for everyone':

- On-line, face to face or a combination
- Not time specific
- Flexible and adaptable to the perpetrators needs
- Focused on abusing the child and benefitting the perpetrator
- Can be perpetrated by males or females against male or female victims
- Can be perpetrated by groups or individuals
- Testing
- Giving gifts/ gaming credits/ vouchers
- Money cost of living crisis
- Providing 'Friendship' safety, belonging, inclusion, a home
- Making promises/threats
- Witnessing or experiencing violence
- Abusing a position of power/trust
- Using someone's aspirations/ faith/ sexual orientation
- Threatening to share recordings or self-generated images
- Telling lies

# Why don't children just tell us what's happening?:

• Feeling of responsibility to earn money for their family

- Wanting to have the same clothes and possessions as their peers to 'fit in'
- Perceived lack of future options
- Fear of violence towards them, their family or people they care about
- Embarrassed of what they've done
- Fear of not being believed
- Unable to speak English
- Debt bondage
- 'All my friends are doing it so it can't be that bad'
- Fear of being taken into care or sent to prison
- Not knowing any different grooming
- Who would they tell?
- 'I have told them and they didn't listen'
- Not wanting to loose their friends

# Some of the potential signs of modern slavery and human trafficking ;

- Going missing
- Not attending education
- Being late
- A change in presentation (appearance/ engagement)
- A change in behaviour
- Giving a rehearsed story when asked questions
- Accompanied or collected by someone for appointments and education
- Someone else speaking for them
- A change in friendship group
- Treated differently to siblings
- Not being registered for education or health services
- Limited freedom of movement
- Indications of trauma; self harm; nightmares etc
- Unexplained money or items
- Unable/ unwilling to provide details of where they've been or who they're seeing
- Substance misuse
- Not sleeping well
- Injuries that could be work related
- Pregnancy/STIs

- Nothing about us without us hear what's not said
- A child cannot be expected to protect themselves from abuse
- Be vigilant, any child can be a victim
- Recognising and responding to modern slavery and human trafficking is all our responsibility
- Be kind
- Don't make assumptions
- Signs are enough, don't wait to report!
- The importance of multi-agency working trust your instincts
- Map what we know
- Every situation is different
- Professional curiosity

It's EVERYONE'S RESPONSIBILITY to recognise and respond to the signs of Modern Slavery and Human Trafficking.

Modern Slavery and Human Trafficking IS CHILD ABUSE.

Child Abuse ALWAYS needs a safeguarding response – do not be afraid to say this.
